As you are aware that, pursuant to the application filed by IDBI Bank Ltd before National Company Law Tribunal, Ahmedabad Bench ("NCLT") in terms of section 7 of Insolvency and Bankruptcy Code, 2016 read with the rules and regulations framed thereunder ("Code"), the NCLT had admitted the application and ordered the commencement of Corporate Insolvency Resolution Process ("CIRP") of Reliance Naval and Engineering Limited ("Corporate Debtor") vide its order dated 15 January 2020 (received on 17 January 2020). Subsequently, vide order dated January 15, 2020, Rajeev Bal Sawangikar was appointed as the Interim Resolution Professional of the Corporate Debtor ("Interim Resolution Professional").

Subsequently, the committee of creditors ("CoC") of the Corporate Debtor, pursuant to the meeting held on March 13, 2020 and in terms of Section 22 (2) of the Code, resolved, with requisite voting share, to replace the existing Interim Resolution Professional with Mr. Sudip Bhattacharya (IBBI/IPA-003/IP-N00080/2017-18/10703) as the Resolution Professional ("RP") for the Corporate Debtor. Upon publication of the Order and/or receipt of a copy of the Order by the undersigned, the requisite disclosure in terms of Regulation 30 read with clause 16(f) of Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 shall be made.

Further, 3<sup>rd</sup> CoC meeting was held on Thursday April 09, 2020 to provide business update, approval of CoC expenses and approval of eligibility criteria to invite Expression of Interest to submit Resolution Plan for Reliance Naval and Engineering Limited. Therefore, the e-voting resolution put to vote at 3<sup>rd</sup> CoC meeting of the Corporate Debtor commenced on Wednesday April 15, 2020 at 10:00 am and concluded on Saturday April 18, 2020 at 06:00 pm.
